HOT BREWING INSTRUCTIONS: Bring filtered or freshly drawn cold water to a rolling boil. Place 1 slightly heaping teaspoon of loose tea for each 7-9oz / 200-260ml of fluid volume in the teapot. Pour the boiling water into the teapot. Cover and let steep for 3-7 minutes according to taste (the longer the steeping time the stronger the tea).

PRESENTATION: Vacuum packed in a custom bag that controls atmospheric pressure. This bag protects it from moisture, oxygen, and light.

STORAGE CONDITIONS: Store in a cool, dry, dark place (15-30 degrees Celsius).

SHELF LIFE LOOSE TEA: 20 years unopened, 2 years after opening.

METHOD OF MANUFACTURE: Raw material is received, tested, and tasted against the standard in accordance to FSSC 22000, FSMA, and SFCR food safety protocols. A retention sample is drawn and kept for fifteen years. The raw material is vacuum packed before storage. When ready to blend, the vacuum packed materials are emptied into a stainless steel blender and sampled for an organoleptic test and further analysis. Vacuum packed before distribution.

PRODUCT ASSESSMENT/ASSURANCE: All ingredients are traditionally used in tea, fruit or herbal blends, and/or food.

ASSESSMENT OF FINAL PRODUCT FOR HUMAN CONSUMPTION: We hereby confirm that all tea products produced and marketed by Metropolitan Tea are suitable for human consumption, proper application provided.
